After phone conversations between Sam and I, it was communicated to me that Cumberland may decide to haul manure out of the state on a yearly basis due to the possibility of lack of acreage within their NMP. The department is requesting an update regarding written verification on the fields within the NMP and an update on shipping manure out of state. If drastic changes need to be made to the NMP or the overall permit application, then the department may consider rejecting the permit application.
